Park admission: \$35 includes all rides and shows at the park

Food:

- Students will be at the park for 2 meals: lunch and supper
- Outside food can be brought into the park, so you may choose to pack a lunch/dinner if you prefer
NOTE: there is no good spot to store food, each student will be responsible for their own packed food.
- Discounted meal vouchers can be purchased for \$15. These vouchers can be redeemed at a variety of food kiosks at the park for one of the following five meals:
